## I. Situation Overview

On 26 March 2024 at around 9:30 AM, a fire incident occurred in Brgy. Paningayan, Laua-an, Antique. The fire was declared out at around 10:25 AM.

A total of \$\mathbb{P}\$,136.00 worth of assistance was provided to the affected families; of which, \$\mathbb{P}\$8,136.00 from DSWD and \$\mathbb{P}\$1,000.00 from the Local Government Unit (LGU) (see Annex D).
