

DSWD DROMIC Report on the Fire Incident in Brgy. Parilla, Palompon, Leyte

02 June 2024, 6PM

I. Situation Overview

On 22 March 2024 at around 1:11 AM, a fire incident occurred in Brgy. Parilla, Palompon, Leyte. The fire was declared on the same date.

II. Status of Affected Areas and Population

A total of **six (6) families** or **18 persons** were affected in **Brgy. Parilla, Palompon, Leyte** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **six (6) families** or **18 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **five (5) houses** were damaged; of which, **four (4) are totally damaged** and **one (1) are partially damaged** in **Brgy. Parilla, Palompon, Leyte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱78,999.24** worth of assistance was provided to the affected families; of which, **₱48,999.24** from **DSWD** and **₱30,000.00** from the **Local Government Unit (LGU)** (see Annex D).
