





# DSWD DROMIC Report on the Fire Incident in Brgy. Parilla, Palompon, Leyte

02 June 2024, 6PM

#### I. Situation Overview

On 22 March 2024 at around 1:11 AM, a fire incident occurred in Brgy. Parilla, Palompon, Leyte. The fire was declared on the same date.

### II. Status of Affected Areas and Population

A total of six (6) families or 18 persons were affected in Brgy. Parilla, Palompon, Leyte (see Annex A).

## III. Status of Displaced Population

#### **Outside Evacuation Center**

A total of **six (6) families** or **18 persons** temporarily stayed with their relatives or friends (see Annex B).

# IV. Damaged Houses

A total of five (5) houses were damaged; of which, four (4) are totally damaged and one (1) are partially damaged in Brgy. Parilla, Palompon, Leyte (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of ₱78,999.24 worth of assistance was provided to the affected families; of which, ₱48,999.24 from DSWD and ₱30,000.00 from the Local Government Unit (LGU) (see Annex D).
