# I. Situation Overview

On 04 March 2024 at around 9:40 AM, a fire incident occurred in Brgy. Poblacion 04, Jipapad, Eastern Samar. The fire was declared out at around 10:15 AM.

A total of **two (2) houses** were **totally damaged** in **Brgy. Poblacion 04, Jipapad**, **Eastern Samar** (see Annex C).

# V. Cost of Humanitarian Assistance Provided

A total of **₱16,306.58** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
