
DSWD DROMIC Report on the Fire Incident in Brgy. Poblacion, Jordan, Guimaras

06 April 2024, 6AM

I. Situation Overview

On 22 February 2024 at around 9:50 AM, a fire incident occurred at Brgy. Poblacion, Jordan, Guimaras. The fire was declared out at around 10:50 AM.

The incident resulted in the complete destruction of a residential structure that housed two (2) family comprising eight (8) individuals. In coordination with the LGU of Jordan, Guimaras, the DSWD through its Field Office in Region VI provided relief augmentation to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

A total of **two (2) families** or **eight (8) persons** were affected in **Brgy. Poblacion, Jordan, Guimaras** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of two (2) families or **eight (8) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Poblacion, Jordan, Guimaras** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱19,851.56** worth of assistance was provided to the affected families composed of **₱16,851.56** from **DSWD** and **₱3,000.00** from the **Local Government Unit (LGU)** (see Annex D).
