### I. Situation Overview

On 20 February 2024 at around 12AM, a fire incident occurred in Brgy. Poblacion, Pasuquin, Ilocos Norte.

**One (1) house** was **totally damaged** in **Brgy. Poblacion, Pasuquin, Ilocos Norte** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱16,000.00** worth of assistance was provided to the affected family; of which, **₱10,000.00** from **DSWD** and **₱6,000.00** from the **Local Government Unit (LGU)** (see Annex D).
