# DSWD DROMIC Report on the Fire Incident in Brgy. Poblacion, San Rafael, Iloilo 

03 April 2024, 6PM

## I. Situation Overview

On 22 March 2024 at around 1:49 PM, a fire incident occurred in Brgy. Poblacion, San Rafael, Iloilo. The fire was declared out at around 2:11 PM.
II. Status of Affected Areas and Population

One (1) family or four (4) persons were affected in Brgy. Poblacion, San Rafael, Iloilo (see Annex A).

## III. Status of Displaced Population

## Outside Evacuation Center

One (1) family or four (4) persons temporarily stayed with their relatives or friends (see Annex B).

## IV. Damaged Houses

One (1) house was totally damaged in Brgy. Poblacion, San Rafael, Iloilo (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of P16,216.00 worth of assistance was provided to the affected families; of which, P6,216 from DSWD and P10,000.00 from the Local Government Unit (LGU) (see Annex D).
