I. Situation Overview

On 22 March 2024 at around 1:49 PM, a fire incident occurred in Brgy. Poblacion, San Rafael, Iloilo. The fire was declared out at around 2:11 PM.

One (1) family or four (4) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Poblacion, San Rafael, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱16,216.00** worth of assistance was provided to the affected families; of which, **₱6,216** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
