I. Situation Overview

On 17 March 2024 at around 5:00 PM, a fire incident occurred in Brgy. Robles, La Castellana, Negros Occidental. The fire was declared out at around 6:15 PM.

II. Status of Affected Areas and Population

Two (2) families or six (6) persons were affected in Brgy. Robles, La Castellana, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center Two (2) families or six (6) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** was **totally damaged** and **one (1)** was **partially damaged** in **Brgy. Robles, La Castellana, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱15,614.00 worth of assistance was provided to the affected families; of which, ₱10,614.00 from DSWD and ₱5,000.00 from the Local Government Unit (LGU) (see Annex D).
