I. Situation Overview

On 02 April 2024 at around 11:55 PM, a fire incident occurred in Brgy. Salihid, Barotac, Nuevo, Iloilo. The fire was declared out at around 1:17 AM.

One (1) family or seven (7) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Salihid, Barotac, Nuevo, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱8,506.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).

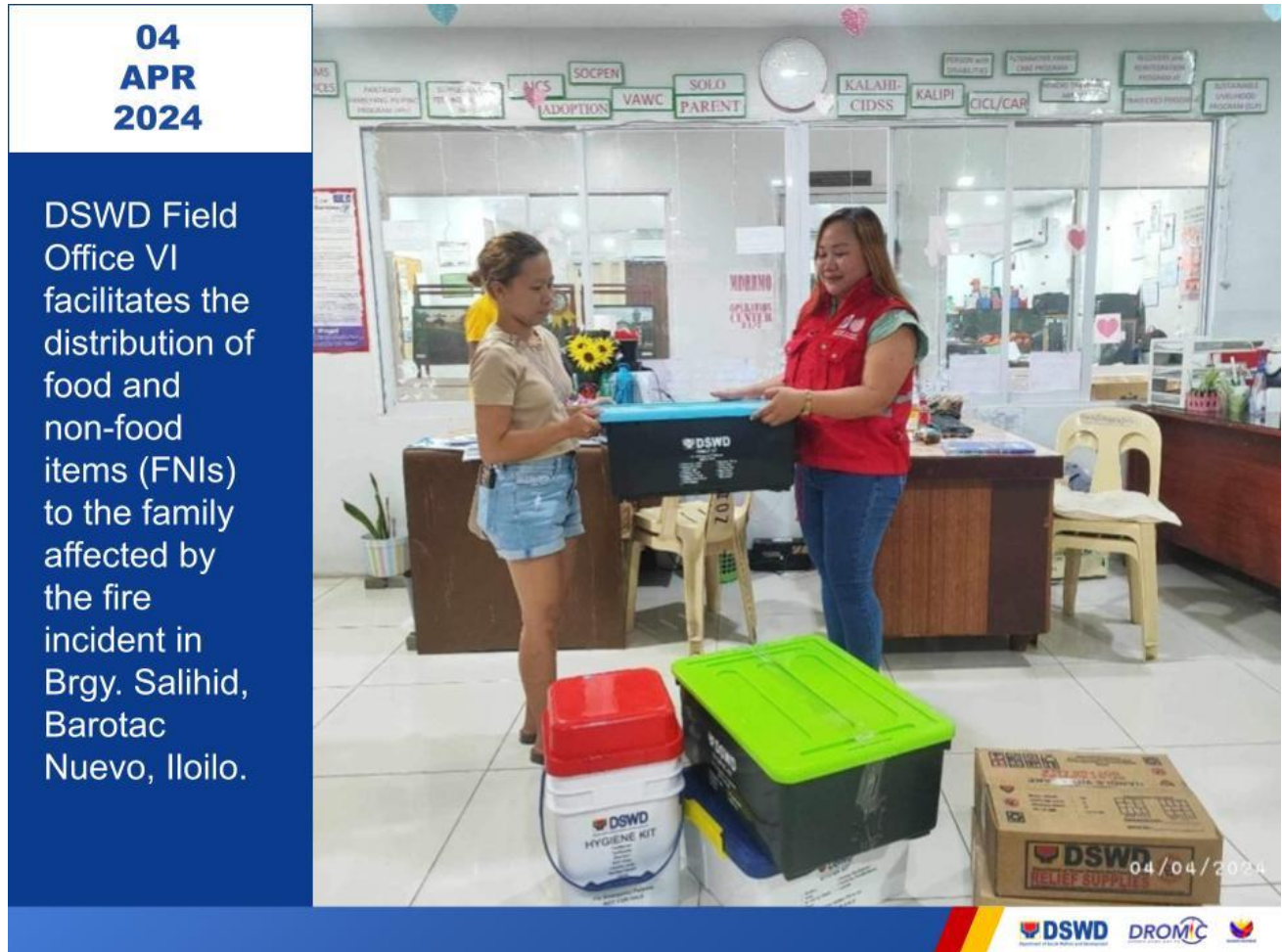
