





# DSWD DROMIC Report on the Fire Incident in Brgy. San Teodoro-Poblacion, Binalbagan, Negros Occidental 11 April 2024, 6PM

#### I. Situation Overview

On 22 March 2024 at around 12:45 PM, a fire incident occurred at Brgy. San Teodoro-Poblacion, Binalbagan, Negros Occidental. The fire was declared out at around 3:10 PM.

# II. Status of Affected Areas and Population

A total of five (5) families or 24 persons were affected in Brgy. San Teodoro-Poblacion in Binalbagan, Negros Occidental (see Annex A).

# III. Status of Displaced Population

#### **Outside Evacuation Center**

A total of **five (5) families** or **24 persons** temporarily stayed with their relatives or friends (see Annex B).

# IV. Damaged Houses

A total of **five (5) houses** were **totally damaged** in **Brgy. San Teodoro-Poblacion**, **Binalbagan**, **Negros Occidental** (see Annex C).

# V. Cost of Humanitarian Assistance Provided

A total of **P39,638.90** worth of assistance was provided to the affected families; of which, **P34,638.90** from **DSWD** and **P5,000.00** from the **Local Government Unit** (**LGU**) (see Annex D).
