





DSWD DROMIC Report on the Fire Incident in Brgy. Sibaguan, Roxas City, Capiz

16 April 2024, 6AM

I. Situation Overview

On 09 April 2024 at around 4:30 PM, a fire incident occurred at Brgy. Sibaguan, Roxas City, Capiz. The fire was declared out at around 5:20 PM.

In response, the DSWD through its Field Office in Region VI, promptly provided relief assistance to support the immediate needs of the affected family.
