I. Situation Overview

On 01 April 2024 at around 10:30 AM, a fire incident occurred in Brgy. Tacas, Miagao, Iloilo. The fire was declared out at around 11:10 AM.

One (1) family or six (6) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Tacas, Miagao (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱5,865.78 worth of assistance was provided by the **DSWD** to the affected family (see Annex D).
