





DSWD DROMIC Report on the Fire Incident in Brgy. Talagacay, Hinoba-an (Asia), Negros Occidental 04 April 2024, 6PM

I. Situation Overview

On 19 March 2024 at around 6:00 PM, a fire incident occurred in Brgy. Talagacay, Hinoba-an (Asia), Negros Occidental. The fire was declared out at around 7:10 PM.

II. Status of Affected Areas and Population

A total of **two (2) families** or **five (5) persons** were affected in **Brgy. Talagacay**, **Hinoba-an (Asia)**, **Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **five (5) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** was **totally damaged** and **one (1)** was **partially damaged** in **Brgy. Talagacay**, **Hinoba-an (Asia)**, **Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱16,206.00** worth of assistance was provided to the affected families; of which, **₱9,206.00** from **DSWD** and **₱7,000.00** from the **Local Government Unit (LGU)** (see Annex D).
