I. Situation Overview

On 03 April 2024 at around 11:00 AM, a fire incident occurred at Brgy. Talaptap, La Castellana, Negros Occidental. The fire was declared out at around 12:15 PM.

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Talaptap, La Castellana, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,307.00** worth of assistance was provided to the affected family; of which, **₱5,307.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
