

## **DSWD DROMIC Report on the Fire Incident in Brgy. Velasco, Lemery, Iloilo**

02 April 2024, 6AM

### **I. Situation Overview**

On 22 March 2024 at around 10:30 AM, a fire incident occurred in Brgy. Velasco, Lemery, Iloilo. The fire was declared out at around 11:00 AM.

**One (1) family or eight (8) persons** were affected in **Brgy. Velasco, Lemery, Iloilo** (see Annex A).

### **III. Status of Displaced Population**

#### **Outside Evacuation Center**

**One (1) family or eight (8) persons** temporarily stayed with their relatives or friends (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Velasco, Lemery, Iloilo** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱10,865.78** worth of assistance was provided to the affected families; of which, **₱5,865.78** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
