

DSWD DROMIC Terminal Report on the Armed Conflict in Brgy. Umiray, Dingalan, Aurora

26 February 2025, 6AM

I. Situation Overview

On 21 April 2024, an armed conflict transpired at Sitio Pinamaypayan, Brgy. Umiray, Dingalan, Aurora between the troops of Armed Forces of the Philippines (AFP) and the members of the Communist Party of the Philippines-New People's Army (CPP-NPA) resulting in the displacement of families and individuals in the area.

II. Status of Affected Areas and Population

A total of **264 families** or **1,135 persons** were affected in **Brgy. Umiray, Dingalan, Aurora** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **67 families** or **268 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of ₱980,294.00 worth of assistance was provided to the affected families; of which, ₱678,014.00 from DSWD and ₱302,280.00 from the Local Government Unit (LGU) (see Annex C).
