





DSWD DROMIC Terminal Report on the Clan Feud Incident in Brgy. Banucagon, Pigkawayan, North Cotabato

18 May 2024, 6PM

I. Situation Overview

On 24 April 2024 at around 4:30 PM, a clan feud incident due to land dispute between two (2) conflicting families transpired in Brgy. Banucagon, Pigkawayan, North Cotabato which resulted in the displacement of the families and individuals in the area.

II. Status of Affected Areas and Population

A total of **184 families** or **920 persons** were affected in **Brgy. Banucagon**, **Pigkawayan**, **North Cotabato** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

A total of **88 families** or **440 persons** sought temporary shelter at the **Municipal Gymnasium** in **Brgy. Poblacion III, Pigkawayan, North Cotabato** (see Annex B).

b. Outside Evacuation Center

A total of **20 families** or **200 persons** temporarily stayed with their relatives or friends (see Annex C).

c. Total Displaced Population

A total of 108 families or 640 persons were displaced in Brgy. Banucagon, Pigkawayan, North Cotabato (see Annex D).

IV. Cost of Humanitarian Assistance Provided

A total of **P723,520.00** worth of assistance was provided to the affected families; of which, **P673,520.00** from **DSWD** and **P50,000.00** from the **Local Government Unit (LGU)** (see Annex E).
