





DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Baresbes, Dingras, Ilocos Norte

19 April 2024, 6PM

I. Situation Overview

On 22 March 2024 at around 5:41 AM, a fire incident occurred at Brgy. Baresbes, Dingras, Ilocos Norte.

Relative to the incident, the DSWD through its Field Office in Region I, provided relief and financial assistance to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or three (3) persons were affected in Brgy. Baresbes, Dingras, Ilocos Norte (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy Baresbes, Dingras, Ilocos Norte (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱21,030.25 worth of assistance was provided to the affected family composed of ₱17,530.25 from DSWD and ₱3,500.00 from the Local Government Unit (LGU) (see Annex D).
