I. Situation Overview

On 04 April 2024 at around 10:21 AM, a fire incident occurred in Brgy. Bateria, Daanbantayan, Cebu. The fire was declared out at around 10:28 AM.

One (1) family or six (6) persons are affected in Brgy. Bateria, Daanbantayan, Cebu (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or six (6) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Bateria, Daanbantayan, Cebu (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱24,431.00 worth of assistance was provided to the affected family; of which, ₱7,431.00 from DSWD and, ₱17,000.00 from the Local Government Unit (LGU) (see Annex D).
