## I. Situation Overview

On 27 March 2024 at around 11PM, a fire incident occurred in Brgy. Buenlag, Binmaley, Pangasinan.

## IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Buenlag, Binmaley, Pangasinan** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of **₱26,730.60** worth of assistance was provided to the affected family composed of **₱16,730.60** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
