I. Situation Overview

On 26 March 2024 at around 8:00 AM, a fire incident occurred at Sitio Puwad, Brgy. Cabetayan, Kabugao, Apayao.

One (1) house was partially damaged in Brgy. Cabetayan, Kabugao, Apayao (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of \$\mathbb{P}33,747.45\$ worth of assistance was provided to the affected family; of which, \$\mathbb{P}18,747.45\$ from DSWD and \$\mathbb{P}15,000.00\$ from the Local Government Unit (LGU) (see Annex C).
