

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Lipit Tomeeng, San Fabian, Pangasinan

22 January 2025, 6AM

I. Situation Overview

On 02 April 2024, at around 1:30 PM, a fire broke out in Brgy. Lipit Tomeeng, San Fabian, Pangasinan.

One (1) residential house was gutted by fire and was declared partially damaged. The affected family established temporary dwelling space within their premises.

Relative to the incident, the DSWD through its Field Office in Region I, together with the Local Government Unit (LGU) of San Fabian, Pangasinan, provided relief assistance to support the immediate needs of the affected family.
