



DSWD DROMIC Terminal Report on the Fire Incident in Brgy.Manalpac, Solsona, Ilocos Norte

19 April 2024, 6PM

I. Situation Overview

On 16 March 2024 at around 9:42 AM, a fire incident occurred at Brgy. Manalpac, Solsona, Ilocos Norte.

Relative to the incident, the DSWD through its Field Office in Region I, provided relief and financial assistance to support the immediate needs of the affected family. Moreover, the LGU of Solsona, Ilocos Norte, assumes the management of Internally Displaced Persons (IDPs) and commits to continuously provide interventions as necessary hence, the termination of this report.

II. Status of Affected Areas and Population

A total of three (3) families or 11 persons were affected in Brgy. Manalbac, Solsona, llocos Norte (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **three (3) families** or **11 persons** are temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy Manalpac, Solsona, Ilocos Norte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱76,120.75 worth of assistance was provided to the affected families composed of ₱48,120.75 from DSWD and ₱28,000.00 from the Local Government Unit (LGU) (see Annex D).
