I. Situation Overview

On 16 April 2024 at around 3:41 PM, a fire incident occurred in Brgy. Maribi, Tanauan, Leyte.

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Maribi, Tanauan, Leyte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱19,377.90** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
