I. Situation Overview

On 27 March 2024 at around 12:00 PM, a fire incident occurred in Brgy. Pinamula, Kibawe, Bukidnon.

A total of **three (3) families** or **15 persons** were affected in **Brgy. Pinamula, Kibawe, Bukidnon** (see Annex A).

There are **three (3) families** or **15 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of three (3) houses were totally damaged in Brgy. Pinamula, Kibawe, Bukidnon (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱17,519.34 worth of assistance was provided to the affected families; of which, ₱4,019.34 from DSWD and ₱13,500.00 from the Local Government Unit (LGU) (see Annex D).
