

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Sto. Niño, Capoocan, Leyte

22 June 2024, 6PM

I. Situation Overview

On 21 April 2024 at around 1:50 AM, a fire incident occurred in Brgy. Sto. Niño, Capoocan, Leyte.

II. Status of Affected Areas and Population

A total of **18 families** or **75 persons** were affected in **Brgy. Sto. Niño, Capoocan, Leyte** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

A total of **five (5) families** or **22 persons** sought temporary shelter in **two (2) evacuation centers** in **Brgy. Sto. Niño, Capoocan, Leyte** (see Annex B).

b. Outside Evacuation Center

A total of **13 families** or **53 persons** temporarily stayed with their relatives or friends (see Annex D).

c. Total Displaced Population

A total of **18 families** or **75 persons** were displaced in **Brgy. Sto. Niño, Capoocan, Leyte** (see Annex E).

IV. Damaged Houses

A total of **18 houses** were **totally damaged** in **Brgy. Sto. Niño, Capoocan, Leyte** (see Annex F).

V. Cost of Humanitarian Assistance Provided

A total of **₱337,217.58** worth of assistance was provided by **DSWD** to the affected families (see Annex G).
