

## DSWD DROMIC Report #1 on the Fire Incident in Brgy. Eheb, Tinoc, Ifugao as of 06 May 2024, 6PM

### I. Situation Overview

On 16 April 2024 at around 3:00 PM, a fire incident occurred at Sitio Kay-ang, Brgy. Eheb, Tinoc, Ifugao.
