





DSWD DROMIC Report #1 on the Fire Incident in Brgy. Panubigan, Canlaon City, Negros Oriental

as of 29 May 2024, 6PM

I. Situation Overview

On 21 February 2024 at around 2AM, a fire incident occurred in Brgy. Panubigan, Canlaon City, Negros Oriental.

Relative to the incident, the DSWD through its Field Office in Region VII together with the Local Government Unit (LGU) of Canlaon City, provided relief assistance to support the immediate needs of the affected families.

II. Status of Affected Areas and Population

A total of three (3) families or 10 persons are affected in Brgy. Panubigan, Canlaon City, Negros Oriental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **three (3) families** or **10 persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Panubigan, Canlaon City, Negros Oriental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of \$\mathbb{P}27,550.50\$ worth of assistance was provided to the affected families composed of \$\mathbb{P}7,550.50\$ from \$\mathbb{D}SWD\$ and \$\mathbb{P}20,000.00\$ from the Local Government Unit (LGU) (see Annex D).

1. Standby Funds

- ₱311.81 million Quick Response Fund (QRF) at the DSWD Central Office.
- ₱5 million available at DSWD FO VII.

2. Prepositioned FFPs and Other Relief Items

- 194,535 FFPs available in Disaster Response Centers; of which, 122,157 FFPs are at the National Resource Operations Center (NROC), Pasay City and 72,378 FFPs are at the Visayas Disaster Resource Center (VDRC), Mandaue City.
- 63,582 FFPs available at DSWD FO VII.
- ₱317.26 million worth of other FNIs at NROC, VDRC, and DSWD FO VII warehouses.

b. Food and Non-food Items (FNIs)

28 May 2024	 DSWD FO VII in coordination with the City Social Welfare and Development Office (CSWDO) of the LGU of Canlaon City, Negros Oriental distributed FNIs to the families affected by the fire incident.

c. Other Activities

DATE	ACTIVITIES
28 May 2024	 DSWD FO VII closely coordinated with the LGU of Canlaon City, Negros Oriental for significant updates and further requests for relief augmentation. DSWD FO VII referred the affected family to the Social Welfare and Development (SWAD) office in Negros Oriental for further financial intervention through the Assistance to Individual in Crisis Situation (AICS). The LGU of Canlaon City, Negros Oriental provided financial assistance to the family affected by the fire incident.
