

## DSWD DROMIC Report #1 on the Fire Incident in Brgy. San Roque, Tolosa, Leyte as of 23 May 2024, 6PM

### I. Situation Overview

On 09 May 2024 at around 10:36 AM, a fire incident occurred in Brgy. San Roque, Tolosa, Leyte.

Relative to the incident, the DSWD through its Field Office in Region VIII, promptly provided relief assistance composed of Food and Non-Food Items (FNIs) to support the immediate needs of the affected family.
