

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Tautag, Pintuyan, Southern Leyte as of 22 May 2024, 6PM

I. Situation Overview

On 18 May 2024 at around 1:30 AM, a fire incident occurred in Barangay Tautag, Pintuyan, Southern Leyte. The incident has led to displacement of a family who opted to stay with their relatives.

In response, the DSWD through its Field Office in Region VIII, promptly provided financial assistance to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or **eight (8) persons** are affected in **Brgy. Tautag, Pintuyan, Southern Leyte** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **eight (8) persons** temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Tautag, Pintuyan, Southern Leyte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,000.00** worth of assistance was provided by the **DSWD** to the affected family (see Annex D).
