

## DSWD DROMIC Report #2 on the Armed Conflict in Brgy. Rogongon, Iligan City, Lanao del Norte as of 08 June 2024, 6AM

### I. Situation Overview

On 31 March 2024, an armed conflict transpired at Sitio Limunsudan, Brgy. Rogongon, Iligan City, Lanao del Norte between the troops of Armed Forces of the Philippines (AFP) and members of unidentified armed groups.
