

DSWD DROMIC Report #3 on the Clan Feud Incident in Brgy. Patadon, City of Kidapawan, North Cotabato

as of 13 June 2024, 6PM

I. Situation Overview

On 15 May 2024 at around 2:00 PM, a clan feud (*Rido*) involving two (2) warring families transpired at Purok 3 and Purok 6, Brgy. Patadon, City of Kidapawan, North Cotabato. The conflict led to a casualty and the displacement of families and persons.

II. Status of Affected Areas and Population

A total of **194 families** or **750 persons** are affected in **Brgy. Patadon, City of Kidapawan, North Cotabato** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total of **194 families** or **750 persons** sought temporary shelter at the **Brgy. Patadon Covered Court** in **Brgy. Patadon, City of Kidapawan, North Cotabato** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱136,850.00** worth of assistance was provided to the affected families; of which, **₱129,010.00** from **DSWD** and **₱7,840.00** from the **Local Government Unit (LGU)** (see Annex C).
