
DSWD DROMIC Report on the Fire Incident in Brgy. Argao, Malay, Aklan 22 May 2024, 6PM

I. Situation Overview

On 29 April 2024 at around 6:02 PM, a fire incident occurred in Barangay Argao, Malay, Aklan. The fire was declared out at around 6:33 PM.

Relative to the incident, the DSWD through its Field Office in Region VI, provided relief augmentation to support the immediate needs of the affected family.
