



# DSWD DROMIC Report on the Fire Incident in Brgy. Bantayanon, City of Kabankalan, Negros Occidental

16 May 2024, 6AM

## I. Situation Overview

On 26 April 2024 at around 6:30 AM, a fire incident occurred in Brgy. Bantayanon, City of Kabankalan, Negros Occidental. The fire was declared out at around 7:45 AM.

#### IV. Damaged Houses

One (1) house was totally damaged in Brgy. Bantayanon, City of Kabankalan, Negros Occidental (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of ₱10,588.00 worth of assistance was provided to the affected families; of which, ₱5,588.00 from DSWD and ₱5,000.00 from the Local Government Unit (LGU) (see Annex D).
