



DSWD DROMIC Report on the Fire Incident in Brgy. Barihan, Malolos City, Bulacan

02 May 2024, 6AM

I. Situation Overview

On 19 April 2024 at around 10:00 AM, a fire incident occurred in Brgy. Barihan, Malolos City, Bulacan.

Relative to the incident, DSWD through its Field Office in Region III, together with the Local Government Unit (LGU) of Malolos City, Bulacan, provided financial assistance to support the immediate needs of the affected families and individuals.

A total of **five (5) families** or **17 persons** were affected in **Brgy. Barihan, Malolos City, Bulacan** (see Annex A).

A total of **five (5) families** or **17 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **five (5) houses** were **totally damaged** in **Brgy. Barihan, Malolos City, Bulacan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱100,000.00 worth of assistance was provided to the affected families composed of ₱50,000.00 from DSWD and ₱50,000.00 from the Local Government Unit (LGU) (see Annex D).
