## DSWD DROMIC Report on the Fire Incident in Brgy. Bolo, Maasin, Iloilo 17 May 2024, 6AM

### I. Situation Overview

On 01 May 2024 at around 2:20 PM, a fire incident occurred in Brgy. Bolo, Maasin, Iloilo. The fire was declared out at around 3:00 PM.
