

DSWD DROMIC Report on the Fire Incident in Brgy. Calabigan, Luna, Apayao

14 May 2024, 6PM

I. Situation Overview

On 18 April 2024 at around 4:00 PM, a fire incident occurred at Sitio Tabas, Brgy. Calabigan, Luna, Apayao. The fire was declared out the same day.

One (1) family or six (6) persons were affected in **Brgy. Calabigan, Luna, Apayao** (see Annex A).

III. Status of Displaced Population

One (1) family or six (6) persons stayed in their newly-built temporary house. (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Calabigan, Luna, Apayao** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱62,637.95** worth of assistance was provided to the affected family; of which, **₱22,637.95** from **DSWD** and **₱40,000.00** from the **Local Government Unit (LGU)** (see Annex D).
