On 02 May 2024 at around 9:20 AM, a fire incident occurred in Brgy. Camansi, City of Kabankalan, Negros Occidental. The fire was declared out at around 10:45 AM.

A total of **₱14,188.00** worth of assistance was provided to the affected families; of which, **₱9,188.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
