

DSWD DROMIC Report on the Fire Incident in Brgy. Caradio-An, City of Himamaylan, Negros Occidental

31 May 2024, 6AM

I. Situation Overview

On 19 May 2024 at around 11:00 AM, a fire incident occurred at Brgy. Caradio-An, City of Himamaylan, Negros Occidental. The fire was declared out at around 12:15 PM.

In response, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of City of Himamaylan, provided relief assistance to support the immediate needs of the affected family.

One (1) family or two (2) persons were affected in **Brgy. Caradio-An, City of Himamaylan, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or two (2) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in **Brgy. Caradio-An, City of Himamaylan, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱17,086.00** worth of assistance was provided to the affected family composed of **₱7,086.00** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).

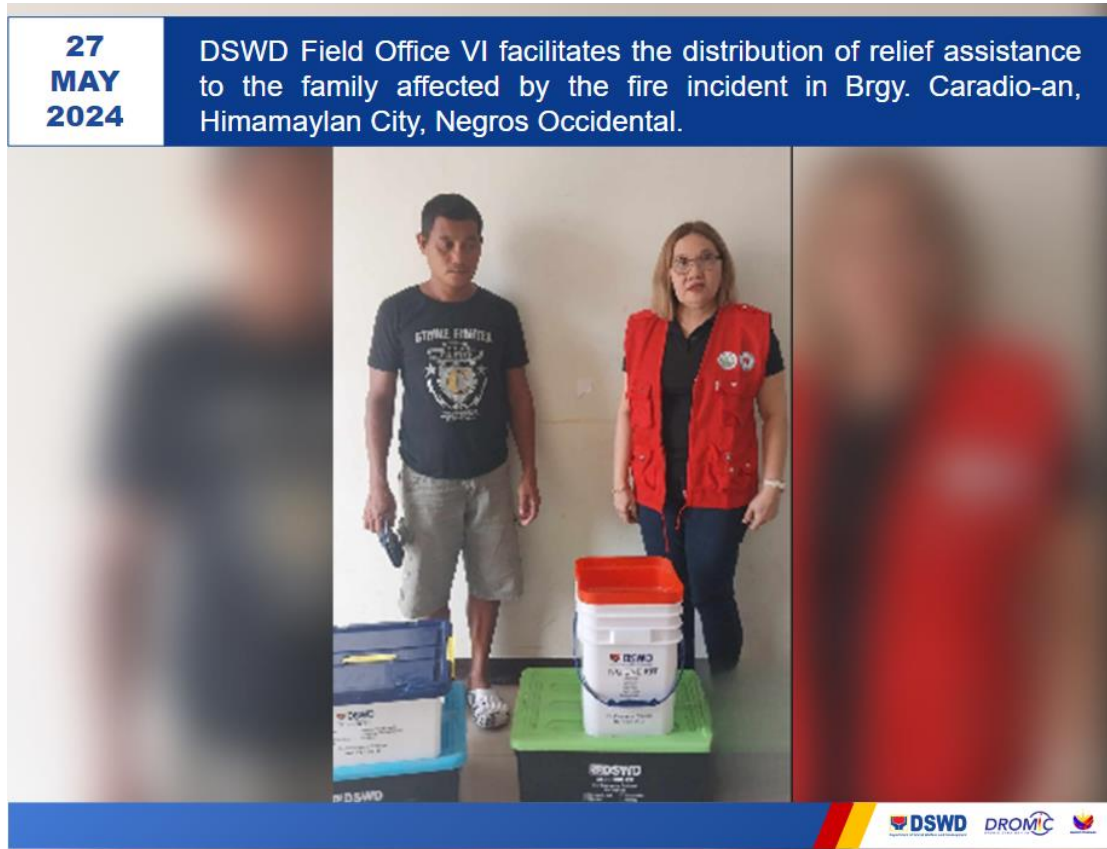
