I. Situation Overview

On 23 April 2024 at around 1:15 PM, a fire incident occurred in Brgy. Carmelo II, San Remigio, Antique. The fire was declared out at around 2:15 PM

One (1) family or six (6) persons were affected in Brgy. Carmelo II, San Remigio, Antique (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or six (6) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Carmelo II, San Remigio, Antique (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱7.365.78 worth of assistance was provided to the affected families; of which, ₱5,865.78 from DSWD and ₱1,500.00 from the Local Government Unit (LGU) (see Annex D).
