

# **DSWD DROMIC Report on the Fire Incident in Brgy. Celestino Villacin, Cadiz City, Negros Occidental**

30 May 2024, 6AM

## **I. Situation Overview**

On 18 April 2024 at around 3:00 PM, a fire incident occurred at Brgy. Celestino Villacin Cadiz City, Negros Occidental. The fire was declared out at around 4:15 PM.

## **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Celestino Villacin, Cadiz City, Negros Occidental** (see Annex C).

## **V. Cost of Humanitarian Assistance Provided**

A total of **₱10,584.00** worth of assistance was provided to the affected families; of which, **₱8,584.00** from **DSWD** and **₱2,000.00** from the **Local Government Unit (LGU)** (see Annex D).
