





# DSWD DROMIC Report on the Fire Incident in Brgy. Celestino Villacin, Cadiz City, Negros Occidental

30 May 2024, 6AM

#### I. Situation Overview

On 18 April 2024 at around 3:00 PM, a fire incident occurred at Brgy. Celestino Villacin Cadiz City, Negros Occidental. The fire was declared out at around 4:15 PM.

#### V. Cost of Humanitarian Assistance Provided

A total of ₱10,584.00 worth of assistance was provided to the affected families; of which, ₱8,584.00 from DSWD and ₱2,000.00 from the Local Government Unit (LGU) (see Annex D).
