I. Situation Overview

On 14 April 2024 at around 9:03 AM, a fire incident occurred in Brgy. Habana, Buruanga, Aklan. The Bureau of Fire Protection (BFP) responded to put out the fire. It was declared fire out at around 10:43 AM.
