## **DSWD DROMIC Report on the Fire Incident in Brgy. III (Poblacion), City of Kabankalan, Negros Occidental**

16 May 2024, 6AM

### **I. Situation Overview**

On 24 April 2024 at around 8:50 AM, a fire incident occurred at Brgy. III (Poblacion), City of Kabankalan, Negros Occidental. The fire was declared out at around 9:45 AM.

**One (1) family or three (3) persons** were affected in **Brgy. III (Poblacion), City of Kabankalan, Negros Occidental** (see Annex A).

**One (1) family or three (3) persons** temporarily stayed with their relatives or friends (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. III (Poblacion), City of Kabankalan, Negros Occidental** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱10,588.00** worth of assistance was provided to the affected families; of which, **₱5,588.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
