A total of **seven (7) families** or **23 persons** are temporarily staying with their relatives or friends (see Annex B).

# IV. Damaged Houses

A total of **two (2) houses** were totally damaged in **Brgy. Look 1**<sup>st</sup>, **Malolos City**, **Bulacan** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of ₱105,000.00 worth of assistance was provided to the affected families; of which, ₱35,000.00 from DSWD and ₱70,000.00 from the Local Government Unit (LGU) (see Annex D).
