I. Situation Overview

On 26 April 2024 at around 1:25 PM, a fire incident occurred in Brgy. Naasug, Malay, Aklan. The fire was declared out at around 2:36 PM.

IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1) is totally damaged** and **one (1) is partially damaged** in **Brgy. Naasug, Malay, Aklan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱9,256.00** worth of assistance was provided to the affected families; of which, **₱8,696.00** from **DSWD** and **₱560.00** from the **Local Government Unit (LGU)** (see Annex D).
