I. Situation Overview

On 07 May 2024 at around 7:10 AM, a fire incident occurred at Sitio Bacuranan, Brgy. Nagba, Maasin, Iloilo. The fire was declared out at around 7:43 AM.

A total of **two (2) families** or **eight (8) persons** were affected in **Brgy. Nagba, Maasin, Iloilo** (see Annex A).

III. Status of Displaced Population

A total of **one (1) family** or **four (4) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** are **totally damaged** and **one (1)** are **partially damaged** in **Brgy. Nagba, Maasin, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱16,832.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
