I. Situation Overview

On 28 April 2024 at around 1:09 AM, a fire incident occurred in Brgy. Napnot, Madalag, Aklan. The fire was declared out at around 1:45 AM.

Outside Evacuation Center

One (1) family or seven (7) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Napnot, Madalag, Aklan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱19,916.00** worth of assistance was provided to the affected family; of which, **₱8,416.00** from **DSWD**, **₱4,500.00** from the **Local Government Unit (LGU)** and **₱7,000.00** from **other Partners** (see Annex D).
