I. Situation Overview

On 28 April 2024 at around 1:09 AM, a fire incident occurred in Brgy. Napnot, Madalag, Aklan. The fire was declared out at around 1:45 AM.

Outside Evacuation Center

One (1) family or seven (7) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Napnot, Madalag, Aklan (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱19,916.00 worth of assistance was provided to the affected family; of which, ₱8,416.00 from DSWD, ₱4,500.00 from the Local Government Unit (LGU) and ₱7,000.00 from other Partners (see Annex D).
